Affected Facility	Hardel Mutual Plywood Corp. 143 Maurin Road Chehalis, WA 98532	
Description of Facility	Hardel Mutual operates a plywood manufacturing plant located in Chehalis, Washington. Facility operations include veneer drying, but no veneer production.	
Source Designation	<u>Synthetic Minor</u> . This facility is a stationary source that would be subject to the Operating Permit Program if a federally enforceable emission limit was not in place. Facility emissions are limited to less than 100 tpy of any single criteria pollutant, less than 10 tpy of any single hazardous air pollutant, and less than 25 tpy of any combination of hazardous air pollutants.	
Purpose of Application	SWCAA has received a permit application for installation of a spray coating operation at the above described facility. The application has not yet been reviewed to determine if it is administratively complete. The SWCAA permit writer identified below will be reviewing the application to make a determination of completeness and, if necessary, make a request for additional information. A copy of the application will be available to the public when the application is determined to be complete.
